### How to realize the export potential estimated at 17 billion Euros in 2026?

On September 26 and 27, 2022, the MED MSMEs Programme organized in Marrakech, in coordination with [Maroc PME](#) and [PortNet](#), two days on the **simplification and digitalization of international trade procedures**. The 40 participants from six southern Mediterranean countries exchanged their experiences in this area (see [summary](#)), discussed a regional one-stop shop and learned about the [EuroMed Trade Help Desk](#), a platform that allows businesses in the Southern Neighbourhood to quantify their export potential (estimated at 17 billion Euros in 2026), by country and by product. The [operating methods](#) of this tool, which covers ten southern Mediterranean countries, were presented by the [EU-TIFM](#) Programme Manager at the International Trade Centre ([ITC](#)).

### Corporate Sustainability Due Diligence: The Proposal European Directive under debate

In collaboration with the EU Delegation in Tunis, a Tabadool dialogue was organized on October 13 by the MED MSMEs Programme on the [Proposal for a European Directive](#) on Corporate Sustainability Due Diligence which would oblige European and non-European companies to publish ESG (environment, social and governance) reports from 2026. The contributions of DG GROW, the Tunis Stock Exchange, CGEM (Morocco), the Egyptian Federation of Industry and the Jordanian Businessmen Association gave participants the opportunity to discuss the potential impact of the proposal directive on SMEs in the southern Mediterranean and the policies to be implemented to transform a threat into an opportunity. ### European Microfinance Week 2022

At the initiative of the European Microfinance Platform ([e-MFP](#)), this hybrid event will take place in Luxembourg from November 16 to 18, 2022. It will bring together global inclusive finance actors (national and multilateral development agencies, investors, NGOs, consultants, researchers, etc.) around more than 30 thematic workshops and networking sessions. ### Bpifrance's "Mondialometer": an online assessment tool for international projects

Any SME with an internationalization project would no doubt be interested: the " [Mondialometer](#) " is an **online tool** that allows companies to carry out a self-assessment in about fifteen minutes. This express diagnosis, designed by Bpifrance, is based on a questionnaire answered by the entrepreneur. It defines the degree of maturity of the project for international business from the point of view of the company's offer, its resources, the market, etc. Personalized recommendations are provided to identify the right levers to activate for a successful internationalization process.

### The Netherlands Enterprise Agency's support for internationalization: an inspiring example

The service offering of this [agency](#) deserves attention because of the **diversity of supports and tools** available to companies seeking internationalization: financing, personalized advice, access to networks and events, databases of foreign markets. This last section contains various market analysis [tools](#) (map of export potential, rules of origin facilitator, etc. ) whose use is facilitated by a [manual](#) from the International Trade Centre. The section also provides access to the [Centre](#) for the Promotion of Imports from Developing Countries, which notably offers market studies (by sector and product group) to SMEs from these countries wishing to export to Europe.

### Green finance promoted by the European Investment Bank in the South-Med region for the benefit of SMEs

The " [EU Trade and Competitiveness Programme](#) ", launched in 2021 by the European Commission and the European Investment Bank in four southern Mediterranean countries (Egypt, Jordan, Morocco, Tunisia), includes among its main axes the strengthening of SMEs' access to finance. The EIB and the Banque Centrale Populaire in Morocco have just concluded the [first guarantee agreement](#) under this Programme. This partnership will facilitate the access of SMEs in four key export sectors (agriculture, agro-industry, textiles, automotive) to **sustainable finance** aimed at improving their competitiveness and their commercial prospects with the EU, particularly through modernization and decarbonization investments.

### Make CSR a lever for international development...

Crossing the issue of **Corporate Social Responsibility** (CSR) with that of the **international development of companies** has been the subject of [work](#) and debate for many years. A [meeting](#) organized with this in mind in a French region by the network of Foreign Trade Advisors was an opportunity to deliver some messages around a triple necessity :

- Rebuilding the entrepreneurial model by integrating CSR as a constant in both internal and international actions.
- Rethinking the enterprise's financing by linking it to a virtuous CSR policy.
- Consider CSR not as a constraint but as an element of differentiation, an opportunity for innovation and progress.

### Fintech and Gender, theme of the next Tabadool dialogue
