# Hybrid regional meeting - Exchange of experiences on the simplification and digitalization of international trade procedures

Marrakech, 26-27 September 2022

#### **Context**

As part of its support activity for SME export development policies and programs, during the first semester of 2022, the MED MSMEs program initiated pilot support projects at national level (Jordan, Morocco and Tunisia) in the areas of digital transformation of exporting SMEs and strengthening the export ecosystem.

The progress of these projects was discussed with the SBA coordinators during the regional meeting held on June 24, 2022 at the headquarters of the Secretariat of the Union for the Mediterranean (Barcelona). At the same time, the national strategies and instruments for supporting the digitalization of SMEs in some partner countries were presented, as well as the support provided by the International Trade Centre-ITC to the internationalization of SMEs in the region.



Given the interest generated by these topics, the SBA coordinators suggested organizing an hybrid regional event on the simplification and digitalization of international trade procedures, including the use of digital single windows.

PORTNET organizing the International Conference and Exhibition on the Single Window in Morocco from September 26 to 28, 2022, an event that will bring together practitioners from 22 countries, it was agreed to organize the MED MSMEs regional event in the framework of the above Conference, thus maximizing the potential for networking and experience transfer.

#### Simplification and digitalization of international trade procedures

The importance of simplifying international trade procedures is evidenced by the establishment of the WTO Trade Facilitation Agreement which aims primarily to improve the efficiency of trade in the world, to encourage economic growth cutting red tape at borders, increasing transparency and taking advantage of new technologies.

Reducing transaction costs is essential to enable SMEs to participate effectively in global value chains (GVCs) and to continue to use international trade as an important engine for growth and sustainable development. Achieving paperless cross-border trade is a long and difficult process, and it cannot be achieved without close collaboration between countries. The MENA region is no exception to the rule: there is an opportunity to increase trade through simplification and digitalization, especially since intra-regional trade is one of the weakest in the world.





To this end, the exchange of experiences in the field of simplification and digitalization of international trade procedures is essential to identify good practices and opportunities for cross-border cooperation in order to improve the trade integration of the region in the benefit of all.



Particular importance will be given to the exchange of information between stakeholders on the different approaches to the implementation of the agreement on trade facilitation signed by certain countries of the region with the WTO (Jordan, Morocco, Tunisia), the strategies and instruments developed (e.g. digital one-stop shops), the difficulties encountered and the solutions found.

In addition to the opportunity to examine the organization and methods of deployment of national electronic single windows, a presentation of the functioning of a regional electronic single window (ASEAN) will be delivered by the Program and discussed with the participants.

## Coordination with other EU regional initiatives & Complementarity with EU bilateral Programmes



This regional event will be closely coordinated with the EU-funded regional program "Trade and Investment Facilitation Mechanism (TIFM)" implemented by the International Trade Centre. A 60-minute session entitled "Supporting SMEs internationalisation in benefiting from regional opportunities" will be organized to

present the TIFM which aims at strengthening trade relations between 10 Euro-Mediterranean countries from the perspective of policy makers, the business community and trade support organisation. Through the recently upgraded Euromed Trade Helpdesk, participants will see how this regional trade portal can support SMEs grow their business, the identification of trade opportunities, market access conditions, trade procedures and business contacts. During the session the participants will also have the opportunity to learn how to access this instrument and to receive useful information aimed at facilitating the access of SMEs in their country.

In addition, EU delegations will be informed and invited to participate in order to identify possible opportunities for support through bilateral cooperation programmes

#### **Purpose and expected results**

The objective of the event is to foster the exchange of information and the transfer of expertise between peers on the implementation of the WTO Trade Facilitation Agreement and related tools (in particular, the electronic single window).





The expected results are as follows:

- More than twenty officials from ministries and agencies responsible for international trade of MED MSMEs partner countries contributed to the exchanges during the event.
- The information and lessons learnt are used at the level of national policies
- Some areas of regional cooperation were identified and discussed.
- The exchange of information and contacts between the participants continue after the meeting.
- Recommendations for follow-up actions are issued, discussed and validated.

The inclusion of this regional MED MSMEs meeting in the work of the Conference and International Exhibition of Single Windows of PORTNET can only amplify the positive effects of exchanges between participants and contribute to the implementation of initiatives to simplify international trade procedures.

#### **Target group**

The target audience includes:

- SBA coordinators / Ministries of Trade, Digital Transition and Transport
- Customs administration / Export promotion agencies / Port agencies
- Private sector representations
- Development partners.

As an indication, the number of participants will be 32 (3 participants per Partner Country, in addition to the SBA coordinator), the PORTNET event bringing together 300+ participants.
